POSITION DESCRIPTION:

This position is to provide customers with efficient and accurate transaction processing with superior and quality customer service.

ESSENTIAL DUTIES:

- Excellent customer service skills following the bank's guidelines/standards
- Good working/understanding of Teller
- Good working/understanding of Item Capture/TCR's
- Good working knowledge of Bank Products and Services
- Good working knowledge of Teller Procedures
- Minimal Errors

EDUCATION AND EXPERIENCE:

- Satisfactory completion of high school, with a diploma or GED equivalent
- MS Office applications experience including WORD and EXCEL

KNOWLEDGE, SKILLS, AND ABILITIES:

- Cash Handling
- Ten Key/Typing by touch
- Ability to work in a fast-paced environment
- Ability to cross-sell bank products
- Ability to troubleshoot issues
- Ability to follow bank policies and procedures
- Ability to communicate effectively with customers and other associates

COMPLIANCE:

The incumbent has the responsibility to acquire and maintain the required knowledge of State and Federal Banking regulations and policies and those regulations and policies inherent to position requirements.

MINIMUM PHYSICAL activity requirements include the ability to:

- Express or exchange ideas by means of the spoken word
- Perceive the normal range of sounds with no less than a 40-decibel loss at 500 Hz and
- 2,000 Hz with or without correction
- Visually identify and distinguish between various documents and currency with normal range of sight having no less than 20/40 to 20/50 vision with or without corrections
- Reach and retrieve objects outside of immediate range
- Stand or support oneself and stay in an upright position
- Raise substantial objects from lower to a higher position or moving objects horizontally from position to position
- Pinch or pick and maneuver small objects by whatever means

The incumbent is not substantially exposed to adverse environmental conditions, but requires sedentary work such as exerting up to 10 pounds of force 5% of the time and a negligible amount of force approximately 90% of the time.
