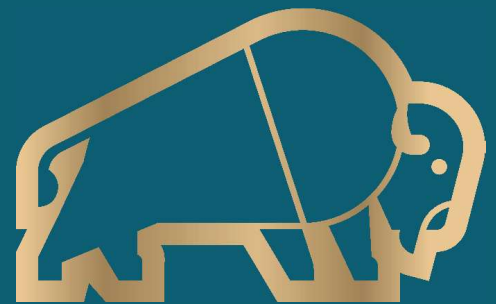


PATRICIA WISE - ASSOCIATE PROFESSOR, WILMINGTON UNIVERSITY SCHOOL OF LAW
