Shults's early interest in flying led her to become one of the first female F/A-18 Hornet pilots in the United States Navy after overcoming several obstacles. At the conclusion of her Navy career, Shults became a pilot for Southwest Airlines. Due to her incredible talent and notable history she been awarded numerous aviation awards, including being inducted into the Texas Aviation Hall of Fame last year.

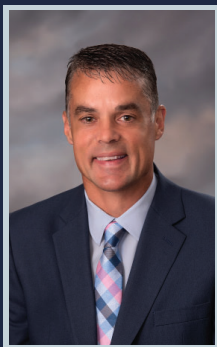
